Professional Media Policy and Procedures.

- Sessions are to be reserved and paid for in advance. We've created an online tool at our [Media Reservations](#) page to help you.
- Fees:
 - During store hours:
 - \$50 for 4 hours. (This is the minimum)
 - \$75 all day (During store hours)
 - Reservations for sessions during store hours are to be made 48 hours in advance.
 - After store hours:
 - \$50 first hour plus \$25 per hour after.
 - You may schedule a session for anytime after store hours until dark, but please note this fee begins immediately after store close.
 - Weekend store hours vary during our festival season. At times this may be to your benefit!
 - Billed in one hour increments only, and the entire session must be scheduled in advance.
 - 5 business day notice required so we can schedule a staff person to be present.
 - We reserve the right to cancel based on staffing availability.
 - Cancellations within 24 hours of the scheduled session are not refundable.
- We understand that it's difficult to work around large crowds. Especially when people tend to walk in front of, or try to photo-bomb the camera! While enjoying your time with us we ask that you also respect other guests as well. Please be kind, gracious, and do your best to not disrupt the experience of others. And please make us aware of those not being gracious to you!

- Mini sessions, static setups, large backdrops, and large props must be pre-approved.
- Please do not pick apples from trees or harvest produce for props unless paying for them at the store when the session is complete. Ours is a food product that we desire not to waste, and are not allowed to sell or serve apples from the ground.
- Stuckey Farm displays or program items may not be moved or manipulated without approval from a team member.
- Identification:
 - Wearing a Stuckey Farm Professional Media Badge w/ Lanyard is required.
 - \$40 Deposit required. Deposit will be returned when media badge is returned.
 - On the day of the photo session, photographers/videographers must pick up the badge at store and return it to the store.
 - For sessions after store hours, the badge may be returned to the team member present.
- Proof of profession required when reserving a session.
 - This may be a website URL, photo of business card, etc.
- Liabilities:
 - Photographer/Videographer agrees to leave property and areas used as they found it.
 - Photographer/Videographer may be held liable for damages to property.
 - Damages to be assessed by Stuckey Farm team member.
- Stuckey Farm has the right to request 3 digital copies, interview segments, or finished video B-roll footage of session results for possible promotional purposes.
 - These will be in coordination with Photographer/Videographer and client.
 - Consent forms will be provided at the time of request.

- Proof of results/outcomes are are required and submitted to Stuckey Farm 7 days after session day.
 - This may be examples and is for proof of purpose only, not for Stuckey Farm promotional use.
 - If the end product is for use on the internet, print or broadcast distribution, please let us know where we can find it. We simply would love to see your great work!
- Credit and hyperlink to “www.StuckeyFarm.com” requested if posted on Professional Photographer/ Videographer’s business website, blog, or social media.
- During Festival hours talent or clients must pay entry fees for each person.
- Stuckey Farm is not responsible for injury, loss or damage.
- Stuckey Farm team members reserve the right to refuse opportunities at any time.
